Dear Students,

Orientation in The Hague is just over three weeks away. I am looking forward to our time together there. Below is some additional information that will help you prepare for the program.

Orientation

Orientation is at 4:00 PM on Sunday, May 27, at The Penthouse, Rijswijkseplein 786. Please plan to arrive in the Hague on Saturday, May 26, so that you will be there in time for orientation.

<u>The Penthouse Restaurant</u> and business suites are located at the top of The Hague Tower, a tall office building next to Den Haag Holland Spoor Train Station. When you enter the lobby of The Hague Tower building, there will be a reception desk. Tell the receptionist you are there for Santa Clara University, and she will direct you to the elevator and the appropriate floor for the business suite in which the orientation will take place.

On time Arrival

I will repeat this more often than you would like to hear it, but it is critical to be on time for all the site visits. We must enter as a group and exit as a group. The courts we are visiting are secure sites; they are part of the UN system. No photos are allowed inside. Bringing a phone or laptop means that you must check it at security, which will delay everyone. If you must bring a phone or laptop, please arrive early to allow sufficient time for security processing. If you are late, we will go ahead without you.

Passport

You will need your ORIGINAL passport to enter the courtrooms. A copy will NOT suffice. Please remember to bring your passport with you for every site visit (including repeat visits to the same institution).

Fun Stuff

If you plan to go away for the weekend, especially to Amsterdam, there are lots of activities and museums. The one I would recommend to all of you is the Anne Frank House/Museum. It can be almost impossible to get admission without an advance booking and tickets. The tickets can be purchased online; I recommend that you do so as early as possible if you plan to go there. Even then, the lines are long, so you should plan to arrive early.
