This is email #3 from the Center for Global Law and Policy with important information leading up to departure.

Please make sure to log in and read all of this information carefully, especially if you just recently submitted your application. A link to the **Facebook group for each program** is available here as well.

A couple of important items:

- On **Wednesday, April 18th** there will be **both an in-person and online version** of the pre-departure orientation. The online version **will be recorded** and sent out for those who could not make it. Expect the general orientation to take about one hour with a brief externship orientation to follow.
  - **For SCU students:** The orientation will be at **12:00pm Pacific in Charney 103 (Panelli Courtroom, corner room)**.
  - **For Non-SCU students:** I will do a webinar style orientation. This will be at **3:00pm Pacific**. More information is available below about how to log in.
- **Full payment is due on April 16th.** Payment can be made via your eCampus account at [ecampus.scu.edu](http://ecampus.scu.edu). **Please review your billing information and registration** to make sure that you are enrolled in the class(es) and externship that you selected, and that the number of units are correct. For those students who enrolled after April 1, your payment deadline will be later. **Do not use SAFARI to make payments.**
  - **For those with financial aid and consortium agreements on file**, payment is due by May 21st. **It is up to you to know if your financial aid will come through by this date.** If it will not, contact the financial aid office at SCU to setup a different schedule. **If you would like to request a custom financial aid budget** separate from what is posted on [our website](http://our website), please email [cglp@scu.edu](mailto:cglp@scu.edu).
- **Please make sure to fill in your passport information and sign the electronic waivers after you have been accepted.** I will be sending out more reminders next week.
  - For non-SCU students, you will need to **print out and sign the signature verification form** and submit this along with a form of ID to [cglp@scu.edu](mailto:cglp@scu.edu).
