# Wednesday, June 27

**Arrive in the United Kingdom and travel to Oxford**. The nearest Airport to Oxford University is London Heathrow where international flights arrive at Terminal 5. You may also fly into London Gatwick which is also accessible by bus to Oxford but father than Heathrow.

Airport transfer to Oxford: Students can book online for a bus transport from the airport to Oxford. The Oxford Bus Company, The Airline, has buses from Heathrow or Gatwick direct to Oxford and return trips: <a href="https://airline.oxfordbus.co.uk/">https://airline.oxfordbus.co.uk/</a>. You may find other transport companies online but the Program Director has had good experience with these companies. Tickets can be booked up to 36 hours in advance, but advanced booking is recommended to reserve a seat. The closest experience with the companies of the

The closest exit to Magdalen College is at the High Street at Queen's Lane, a one block walk to Magdalen College. Alternatively, you can exit at the final bus stop at the Gloucester Green bus station and take a taxi to Magdalen College at the taxi stand (walk through the market area to the taxi line). The bus ride takes approximately 80 minutes. You should be at the bus stop at the airport or in Oxford at least 20 minutes prior to the scheduled departure to ensure you make the bus. The bus companies recommend arriving at the airport one hour before your scheduled airline check-in opening for your departure from the U.K. If you arrive at Oxford by train you will find a taxi next to the train station. Take the taxi to Magdalen College, High Street entrance.

My husband and I took a bus to and from Oxford through the Oxford Bus Company, The Airline, <a href="https://airline.oxfordbus.co.uk/">https://airline.oxfordbus.co.uk/</a> when we attended the 40<sup>th</sup> Anniversary of Women Rhodes Scholars Reunion at Oxford University in September 2017. The bus was convenient, clean, and speedy and we plan to use it for our air transfers to and from Oxford this summer. A taxi from Heathrow to Oxford will cost over \$100, and more from Gatwick. I took the airport bus when I was a student at Oxford, when I visited in September 2017, and plan to do so for our summer law program at Oxford.

*Pronunciation guide*: Please note that Magdalen College's name is pronounced like the word "maudlin," though you will find Magdalen a joyous and beautiful

place with a deer park! Gloucester Green is pronounced like "Glouster" Green. By the time you leave you'll speak the Queen's English!

Arrive at Magdalen College, Oxford. Enter on High Street and introduce yourself to the Porters (official gatekeepers of the college). They will direct you to the Archway Seminar Room where you will check in for the Santa Clara University School of Law Summer Law Program at Oxford University.

Check in with the Program Director. 10:00 a.m. and noon, and 2:00 p.m. to 6:00 p.m. To arrange for earlier or later check in, please email Professor Sandoval at: <a href="mailto:Csandoval@scu.edu">Csandoval@scu.edu</a>. At check-in you will obtain room assignments and keys, schedule updates, Wi-Fi user name and password, Oxford visitor information, your meal card, and other program information. Professor Sandoval's husband, Steve Smith, will join us on check-in day. He will be happy to have an opportunity to meet each of you before he returns to America on June 28. Professor Sandoval will be with you as the Program Director in Oxford through the duration of the program which ends on July 27.

Meals on your own on Wednesday. We'll arrange for an informal no host Oxford pub visit on Wednesday night. Details will be provided at check in.

Casual dress, no shorts please. Students will take a formal oath where you will swear not deface books or to throw the books on the pyre. The admission ceremony is important and necessary for your access to Oxford's world-class libraries.

The Oxford Library admission oath: "I hereby undertake not to remove from the Library, or to mark, deface, or injure in any way, any volume, document, or other object belonging to it or in its custody; not to bring into the Library or kindle therein any fire or flame, and not to smoke in the Library; and I promise to obey all rules of the Library."

4:00 p.m. **Introductory meeting with your tutor** (unless co-director notifies you of different arrangements) at locations to be announced. You and your tutor will schedule subsequent meeting times and your tutor will discuss his or her expectations. You will meet with your tutor at least five times. Some tutors will set this first meeting as a substantive tutorial and send reading and assignments in advance. We will let you know about the reading by the end of May so you can prepare for your first tutorial. Please avoid scheduling a tutorial during other program events: 1) Lecture seminar meeting (generally Mondays from 4:00 pm through 7:15 pm, and Monday, July 23 from 10:00 am to 2:00 pm and 4:00 pm to 7:15 pm, and Wednesday July 3 and July 11 from 4:00 pm to 7:15 pm), the tour of the Oxford courts (July 12), and the tour of "legal London" (July 18).

9:15 departure for 9:30 Orientation and Induction to the Bodleian Law Library: Assemble at and depart promptly from the Magdalen Porter's Office, Orientation and induction to Bodleian Law Library (St. Cross building), 9:30-10:30. Casual dress, no shorts please. Students will receive an introduction to the Bodleian law library system and library privileges.

The Bodleian does not provide summer law students with Westlaw or Lexis access. *Please check with your home institution on Westlaw and Lexis access during the summer to support your research.*

Wear *comfortable*, *sturdy walking shoes* as we'll walk through the Oxford City Center to Port Meadow, then walk on the meadow path which may be muddy, cross the river to the Perch and its beautiful garden. Port Meadow is a wonderful counterpoint to the much-touted "tragedy of the commons" as it has successfully served and been owned in common by the people of Oxford for more than one thousand years. If you would like Professor Sandoval to review a draft of your paper submit it to her at Csandoval@scu.edu by Friday, August 3 at 11:00 p.m. (Eastern **Standard Time**). Your draft should be fully and properly proofread, using footnotes in full bluebook style. Your draft can repeat full citations in place of the id. citation to facilitate revisions for your final paper. Drafts that are poorly proofread, with citations obviously missing or in error, will be returned without full review and will preclude an "A" grade for the paper. Cite sources appropriately, both for the DRAFT and for the final paper. Please submit a wellprepared, solid draft with proper citations and footnotes and good legal analysis reflecting your research and the writing skills you honed from your Oxford tutorials. Both your paper Draft and final paper are subject to Santa Clara University School of Law's Academic Integrity policy available at: http://law.scu.edu/bulletin/academic-integrity-policy/. Please review the policy guidelines to avoid plagiarism. The Plagiarism policy applies to the paper Draft, as well as to the final paper. Citations increase the authority for your paper and should be used fully and appropriately.

# August 24: <u>FINAL Paper due to Professor Sandoval by 11:00 pm. (PACIFIC Standard Time)</u>

Submit your final 20 page paper (approximately 6,500 to 7,000 words) to Professor Sandoval at <a href="mailto:Csandoval@scu.edu">Csandoval@scu.edu</a> by Friday, August 24 at 11:00 p.m. Pacific Standard Time. Your final grade will be submitted shortly after this date so extensions will not be possible except for extraordinary reasons such as medical excuse with a doctor's note. Papers will be graded based on the depth of your analysis and research, legal analysis and argument, organization, writing, proofreading, proper use of citations, and bluebooking. Papers will be graded by Professor Sandoval and will result in the award of two credits when successfully completed.

#### **Tutorials**

Each student schedules five tutorial sessions with their assigned tutor. <u>In agreeing to a schedule with a tutor please do not schedule tutorials at times that conflict with any of the seminar meetings or field trips.</u> A program schedule will be provided to the tutors.

## Planning your flights

You should plan your flight to the United Kingdom to arrive in London (typically Heathrow or Gatwick) not later than the morning or early afternoon of Wednesday, June 27, 2018, enabling you to reach Magdalen College, Oxford, prior to the end of that day's check-in period at 5:00 p.m. Estimate 3 hours from landing at Heathrow to Oxford or 5 hours from landing at Gatwick to Oxford (immigration processing, baggage retrieval, bus ride). Please note that flights from the west coast will require departure on Tuesday, June 26 to arrive in the UK by June 27 for the check in at Oxford for the summer law program.

Please see the note above regarding ground transportation from Heathrow or Gatwick Airport to Oxford.

Unless you plan to spend time in the United Kingdom after the end of the program, you should plan your flight out of the United Kingdom on Friday, July 27, 2017. Some flights back to the United States may leave very early on that morning. There are very early buses from Oxford to both Heathrow and Gatwick. Please check the bus schedules prior to booking your plane flight so you can ensure timely arrival at the airport. If you plan and early or late flight, please make advance check out arrangements with the Program Director.
