A reminder that tuition is due on **Monday**, **April 16th**.

- Payment can be made via your eCampus account at <u>ecampus.scu.edu</u>. Please review your billing information and registration to make sure that you are enrolled in the class(es) and externship that you selected, and that the number of units is correct. For those students who enrolled after April 1st, your payment deadline will be later.
- Do not use SAFARI to make payments.
- For students in the **Geneva or Oxford programs, housing payments** are made via your eCampus account as well. These are also due on **April 16th**.

For financial aid students, the deadline is **Monday, May 21st**. For **non-SCU** financial aid students, a consortium agreement MUST be on file in order to have this deadline.

- It is up to you to know if your financial aid will come through by May 21st. If it will not, contact the financial aid office at SCU (lawfinancialaid@scu.edu) to setup a different date.
